## **Livestock Found — Oklahoma**

LMA has learned that Carter County Deputy Gary Smith has found several head of cattle south of Wilson, Oklahoma. His investigation has determined the cattle showed up around Oct. 9, 2009. A complaint of the cattle being stray in a yard and no owners being found prompted the S.O. to pick up the cattle. They are mostly black cattle or black white-faced cattle and are in excellent condition. The calves in the group have not been branded. There are also some bull calves in the group. There is a deep red colored full grown bull in the group. He is very tame and has been described as remarkable looking – almost show type animal. A Slash S and a S Slash brands have been found on cattle in the group. The brand is located high on the left hip.
