Strayed, Missing or Stolen Livestock — Wyoming

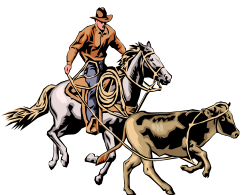


